- UKDA has extensive experience in this sub-theme, both as holders of the CESSDA Presidency from 2005-2010 and due to its direct contribution to activity under the PPP in Eastern Europe, the Balkans and Russia.
- It has existing collaborations with NGOs and with international data providers in its management capacity for the ESDS International Service.
- UK Data Archive contributes to the continued development of the UK Social Science Data collections policy.

Strengths of GESIS as the base for a German Contribution

European and International Comparative Data

Per its design as a European infrastructure, the new CESSDA will naturally be regarded as the resource for access to truly 'European' data. GESIS has, at its Data Archive department, built the largest collection of internationally relevant comparative survey programmes in Europe and is recognized across the world as a site with particular expertise in this area. GESIS is the site where most of the ongoing integration and distribution of surveys such as the Eurobarometers of the European Commission, the European Values Study, the International Social Survey Programme, the Comparative Studies of Electoral Systems and the European Election Study (now PIREDEU) are performed, in close interaction with the primary researchers or data providers of these programmes. The GESIS Archive department has built a massive specialisation in the complete and deep documentation and harmonisation of such surveys, in particular relating to matters of the harmonisation of such complex data sets across countries and time. This is complemented by further GESIS departments working in the comparative areas, but concentrating on study design, methodology and data collection (for the European Social Survey, the European Values Survey, the International Social Survey Programme and others). Thus, GESIS has unique experience in building gateways for the direct interaction between the data-archiving

infrastructure to be maintained by the new CESSDA and many research and data collection projects.

The well-established strength in comparative survey data is now increasingly matched by a parallel development with regard to so-called micro data from official statistics, where GESIS is extending its services in the processing and provision of German micro data to the provision of data at the European level.

European Researcher Access and Training Facilities

A core tasks for the new CESSDA will be to train the staff of full, designate and associate members towards the postulated standards and best-practices. Currently, no institution can claim long experience with systematic training programmes on common data archiving processes, because the definition and implementation of such processes is one of the newly introduced unique features of the new CESSDA. However, proven experience in managing the required staff exchange processes and training events will be an essential prerequisite for establishing a successful training system.

With the EUROLAB as a very well recognized access facility for European researchers, the annual ‘Spring Seminars’ for statistical methods training, and participation in the ESS training programme as well as with its own workshop programme, GESIS has demonstrated expertise in handling the required processes for many years. This experience can be transferred to the systematic training in data documentation and archiving methods, and many of the existing structures and even brand names can be brought to bear for this new purpose.

Safe Data Services

One of the instances where CESSDA will have to respond to new settings and demands was identified above to be the provision of access to data with disclosure risks. Again falling back on existing resources and experiences, GESIS is very well positioned to drive such services. The ‘German MicroData Lab’ is a long-standing structure for processing and integrating disclosive micro data and is extending its activities to the European sphere. The EUROLAB has similar functions for providing on-site access to restricted survey data to international guests. Establishing a remote-access facility for disclosive data is currently under consideration.

National PID Provider for Social Science Data in Germany

GESIS is a member of the international DataCite initiative, which is a group of large scientific information institutions (libraries and data repositories or registries) from several countries. The DataCite initiative has – compared to similar ventures – arguably the largest potential with regard to establishing one central system of research data identification. In cooperation with DataCite, GESIS is currently building an infrastructure for the provision of Persistent Identifiers for social science data held in German repositories. GESIS will thus be among the first social science institutions worldwide with experience in installing and maintaining a PID system. The technology is easily scalable for an application to international settings.

General Portal Concepts and Web Technologies

Processing, finding, connecting and distributing information is at the heart of the activities of an infrastructure for the provision of research data. More concretely, the

new CESSDA will continuously have to improve its data portal, and develop new applications connected to it, such as the data harmonisation portal and the planned Question Database. Apart from the data archiving department already being part of the current CESSDA portal structure, GESIS avails of two scientific departments specialised in the technical and informational design and maintenance of such facilities, the departments for Informational Processes in the Social Sciences (IPS) and for Specialised Information for the Social Sciences (FI). This unique combination is found nowhere else among the institutions that are currently candidates for becoming national service providers in a future cessda-ERIC.

Metadata Standardisation and Best-Practices

Using a common metadata model and shared working protocols is at the heart of a distributed data infrastructure. The most relevant upcoming metadata standard is DDI 3. GESIS has led an international project that already informed the development of DDI 3 (MetaDater, funded under FP5) and since has even increased its activities in the DDI community. GESIS contributes both to continued development of DDI and to training events.

General archiving and data processing best-practices are a less formalised area that still awaits further specification by the new CESSDA. Being home to Europe's oldest and largest Social Science data archive, it is obvious that GESIS has accumulated massive working knowledge

Development of Data Documentation Tools

Hand-in-hand with the development of standards and best-practices, GESIS has an excellent track record in the development of software tools for (meta-) data documentation, in particular for handling the complex international studies and the provision of high-quality or added-value documentation of research data. Proof of this are the leadership of the CESSDA-PPP work package for a data harmonisation infrastructure and question database, development of the questionnaire documentation system QDDS, and the long-standing development work invested into tools such as the Dataset Documentation Manager and the Codebook Explorer, which can be used as internal workflow tools for processes in data archiving, but can also be used for data documentation and organisation by researchers.
